SUBJECT: Purchase of Altec AT 40G Bucket Truck

\_\_\_\_\_ HYDROELECTRIC

### **RECOMMENDATION:**

Approve the purchase of an Altec AT40-G telescoping aerial bucket truck with a Ford F550 chassis from Altec in Dixon, CA in the amount of \$144,967.16 and authorize the Interim General Manager to execute the appropriate documents.

## **BACKGROUND**:

The attached quotation for an Altec AT40-G telescoping aerial bucket truck with a Ford F550 chassis was acquired using the Sourcewell cooperative purchase agreement. Sourcewell is a public agency that offers competitively solicited purchasing contracts for products and equipment to member agencies. The District uses Sourcewell on unique purchases where the District's buying power and staff expertise on the equipment are limited. In 2017 the District used Sourcewell to purchase the Vac-Con Hydro Excavator truck. Prices are negotiated by Sourcewell and agreed upon through a cooperative purchasing group. This process streamlines procurement by developing requests for proposals for national distribution resulting in competitive solicitations that typically meet or exceed local requirements.

The District does not own any telescoping vehicles for lifting employees. Aerial lifting devices have been rented on a routine basis to service a variety of critical infrastructures including; electrical equipment mounted on towers, power poles, security camera networks, tree trimming for fire protection around powerhouses and transmission lines, elevated lighting for buildings and parking areas, remote solar panels used to monitor canal and lake levels, and aerial mounted cables to support the SCADA network.

Renting equipment throughout the year is not cost or time effective. Rental equipment that is not ideally suited for certain types of work may require an employee to pick it up and deliver using a large dump truck and a flatbed trailer. Remote work locations can require up to a full day of transportation each way by a person with a commercial drivers license. The Altec bucket truck can be driven directly to the worksite by the employee completing the work.

This Altec bucket truck would be utilized by different departments throughout the District resulting in cost savings, enhanced employee and public safety, increased reliability and decreased response times.

This item is in alignment with Goal Nos. 1 and 4 of the District's Strategic Plan to maintain internal resources and look for additional processes and technologies that allow greater efficiency.

### **BUDGETARY IMPACT:**

The 2021 Hydroelectric Maintenance budget includes \$170,000 in 50167-52904 for the purchase of a 4X4 bucket truck. This purchase is \$25,032.84 less than the budgeted amount.
