RECOMMENDATION:

Adopt a Resolution approving an amendment to the FY 2025 Capital Budget in the amount of \$23,135 to carry forward unspent appropriations from the FY 2024 Capital Budget encumbered for the Dutch Flat No. 2 Powerhouse Standby Generator Upgrade Project No.2483 (Project) in Fund 55.

BACKGROUND:

On October 9, 2024, the Board adopted the FY 2025 Budget, including the Capital Budget. In preparation for the FY 2025 Budget, estimates were made for ongoing FY 2024 projects to determine if those projects were going to be completed in 2024 or would finish in 2025.

Since the FY 2025 Budget was adopted, this Project, with FY 2024 appropriations, was not completed and need to be disencumbered and reappropriated in FY2025. The total amount is \$23,135 in Hydroelectric Capital Fund 55.

This Project was delayed due to longer than expected lead time for the equipment that arrived after the scheduled outage in 2024. The equipment will be installed during the next outage in 2025. As a result of the delay, additional design expenses will be incurred.

BUDGETARY IMPACT:

The impact of the requested budget amendment is an increase to the Hydroelectric Capital Fund 55 Budget in the amount of \$23,135. This is to carry forward unencumbered appropriations from FY 2024. Moving the appropriations from the prior year has a net zero impact on Fund Balances.

WHEREAS, the Nevada Irrigation District (District) Board of Directors adopted the FY 2025 Annual Budget on October 9, 2024; and

WHEREAS, the FY 2024 Capital Budget has been accounted for through the yearend process, and this project was not completed in FY 2024, requiring the remaining FY 2024 appropriations to be disencumbered and reappropriated in FY 2025 in the amount of \$23,135.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of Nevada Irrigation District:

 FY 2024 Capital Budget will be disencumbered in the amount of \$23,135 in Hydroelectric Capital Fund 55. The funds will be reappropriated in the FY 2025 budget to Project 2483 – Dutch Flat No. 2 Powerhouse Standby Generator Upgrade in the amount of \$23,135 to account 55112-52950-2483.
