
**WHEREAS**, the Nevada Irrigation District orders an election to be held in its jurisdiction on November 5, 2024, at which election the issue(s) to be presented to the voters shall be:

## NOMINATION OF CANDIDATES FOR THE GOVERNING BODY OF THE NEVADA IRRIGATION DISTRICT

 Said election shall be to fill a vacancy for the following Board Member(s) who resigned and/or whose term(s) expired:

- Said Directors for this District are elected by Division. Districts are split into areas; only those voters residing in the area may vote for candidates who run in the area; and
- 3. Said District has determined the following election particulars:
  - The length of the Candidate Statement shall not exceed <u>200</u> words
  - The cost of the Candidate Statement shall be paid by the Candidate; and
- 4. Said District does not request that a measure be decided at this election; and
- 5. Nevada Irrigation District has determined the following election particulars:
  - In the case of a tie vote, the election shall be determined by LOT.
  - The County Clerk is <u>requested</u> to provide election services. All applicable costs for election services provided by the Placer County Elections Office will be paid for by the District.
