- 2. Said Directors for this District are elected by Division. Districts are split into areas; only those voters residing in the area may vote for candidates who run in the area; and
- 3. Said District has determined the following election particulars:
 - The length of the Candidate Statement shall not exceed 200 words
 - The cost of the Candidate Statement shall be paid by the Candidate; and
- 4. Said District does not request that a measure be decided at this election; and
- Nevada Irrigation District has determined the following election particulars:
 - In the case of a tie vote, the election shall be determined by LOT.
 - The County Clerk is <u>requested</u> to provide election services. All applicable costs for election services provided by the Nevada County Elections Office will be paid for by the District.


