The Board of Directors of the Nevada Irrigation District convened in regular session at the District's main office located at 1036 W. Main Street, Grass Valley, on the 8th day of May 2024, at 9 a.m.

M/S/C Hull/Heck, unanimously approved as submitted.

HARRIS ROAD DISTRICT FINANCED WATERLINE EXTENSION (DFWLE) PROJECT NO. 2650

Adopted Resolution No. 2024-17 approving:

- 1. Amendment of Fund 15 Capital Budget in the amount of \$1,449,574**
- 2. Awarding a construction contract with LaFluer Excavating, Inc. in the amount of \$1,165,320 plus a 10% contingency totaling \$1,281,852 for the construction of the Harris Road DFWLE Project and authorizing the General Manager to**

execute the necessary documents and any contract change orders within the contingency amount.

M/S/C Hull/Heck, unanimously approved.

PURCHASE OF REPLACEMENT AIR COMPRESSORS

Approved the purchase of two (2) 2024 Bobcat PA250V Tow-Behind Air Compressors for a total cost of \$88,675.90 from Saba Holding Company, LLC, dba Volvo Construction Equipment and Services, in Sacramento, California, and authorized the General Manager to execute the appropriate documents. M/S/C Hull/Heck, unanimously approved.

WARRANTS, PROJECT AND FACILITY REPORT, AND INVESTMENT REPORT

Ratified the issuance of warrants by receiving and filing the check registers, the Project and Facility Report, and the Investment Transaction Report for the period April 12, 2024 through April 26, 2024. M/S/C Hull/Heck, unanimously approved.

WORKSHOP ITEMS

PG&E UPDATE

President Johansen introduced Brandon Sanders, Senior Representative with Pacific Gas and Electric Company.

Board discussion ensued regarding the following:

- Inquiry as to the vulnerability on the balance of pipe under ownership & responsibility of PG&E should a similar rockslide occur
- Is there anything else that can be done to strengthen the pipe under PG&E's care
- Removal of boulders from above
- Clarified the South Yuba Canal will not be out of commission
- Timing on demolition – 2nd horn
- Confirmed PG&E is now providing sufficient schedules with regular updates to NID Management Staff
- Clarified June 18th is the date for partial restoration of flows into Rollins, and approx. 50 cfs can be spilled back over into the South Yuba Canal, which will then go into Scotts Flat
- Cascade for water treatment and cost to run pumps until full restoration
- When will flows be sufficient to generate power from NID powerhouses
- How often is PG&E required to perform inspections? It would be helpful to better understand the systematic approach to the ongoing maintenance of this system that is so important to our District
- Inspections of columns, indicators, and what was done
- Will there be a conversation on the agreement in place, cost sharing, and responsibilities for S. Yuba Canal and Spaulding I & II and making sure this does not happen again
- Requesting access
- Maintenance and Inspection Schedule and District is receiving sufficient reports from PG&E

- South Yuba River is extremely high and unsafe
- Inquired how flows that will become available approximately June 18th meet community needs
- Observation made on efficient management of canals
- Inquired when the Board can anticipate reservoir storage modeling for the remainder of this year and next year
- Voluntary reduction program for ag water users
- To understand Powerhouses 1 & 2, requested monthly projection records for the last five years to show kilowatt hours and understand value as powerhouse vs. value as water
- Visual of a map, where a small portion of water can spill back into S. Yuba below the break after the June 18th repair

Director Bierwagen, Division II, reported on the following items:


- Attended a Nevada County Farm Bureau meeting
