

Board of Directors gears up for 2025:

President/VP appointed, and incumbent and new director sworn in

Nevada Irrigation District (NID) Directors welcomed new members and elected officers for next year, during their Dec. 11, 2024, meeting.

Director Ricki Heck will serve as Board President, and Chris Bierwagen will serve as Vice President. Heck (Division I) represents portions of Nevada City and Grass Valley. Bierwagen (Division II) represents the Chicago Park area.

NID welcomes a new member to its Board of Directors. Longtime Rancher Brad Fowler (Division III) was sworn in on Dec. 11. Fowler defeated incumbent Karen Hull in the recent election. Division 3 includes Alta Sierra and Lake of the Pines in Nevada County, as well as a portion of northern Placer County.

In addition, Incumbent Director Rich Johansen (Division V), who ran unopposed in the recent election, was sworn in for his second term. First elected to the seat in 2020, his new term will expire in 2028. Division 5 includes Lake Wildwood and Penn Valley.



NID closes foothill boat launches to address threat of invasive golden mussels

No motorized watercraft allowed on Scotts Flat, Rollins reservoirs







The freshwater bivalve can block water intakes and infrastructure, harm native species, increase water clarity due to intense filter feeding and diminish water quality.

"NID will immediately implement a temporary boat launch closure due to the recent discovery of the golden mussel in the Sacramento–San Joaquin Delta. The golden mussel is probably one of the most invasive species we could get and would not only destroy our powerhouses but could also overtake the canal systems," said Greg Jones, NID's assistant general manager.

On October 17, the California Department of Water Resources (DWR) reported finding adult golden mussels at the Port of Stockton. The species is originally from China and Southeast Asia, and it was the first time they had been detected in North America. State officials called the situation a "significant immediate threat."

One concern is the mussels will spread to other waterways, such as NID

reservoirs in the foothills. To address the immediate threat, the District will temporarily close all launches to motorized boats at Scotts Flat and Rollins reservoirs. This includes Long Ravine, Orchard Springs and Greenhorn at Rollins, as well as the Scotts Flat boat launches on both the Cascade Shores and Scotts Flat sides.

"While no golden mussel has been detected at NID facilities, we cannot take a chance," Jones said. "This invasive species could significantly damage the District's infrastructure and the ecology of waterbodies."


She loved golf and was the first woman president of the Nevada County Country Club. Karen had a great love for the outdoors and people. Cross country skiing was her favorite winter activity.

Lawrence Sorensen


Longtime employee Lawrence Sorensen passed away on Christmas Day 2024.

SAFETY CORNER



Curb your bad driving

Slow down!

Driving an NID vehicle means you can never hide behind the steering wheel. Your every driving move – especially the bad behavior – is on full display behind that bright blue logo on the side of your truck or SUV.

The public recognizes that logo, and people instantly know who to call with complaints. Our customer service and safety office deal

with calls every month. The most common complaint is driver speeding.

Here's a reminder to slow down.

Speeding is one of the most dangerous driving behaviors, causing for one out of every three crashes. Plus, the probability of death or serious injury grows with impacts at higher speeds—doubling for every 10 MPH over 50 MPH that a vehicle travels. Here are some reminders of good driving behavior:

Slow down. Speeding won't get you where you're going any quicker – it will only increase your chances of not getting there at all.

Come to a full stop at red lights and stop signs

Avoid running yellow lights.

Don't follow other drivers too closely

Allow for some extra space between you and other vehicles, even if they are driving slower than the speed limit.

Allow more time to get to your destination

If possible, alter your schedule to avoid driving during peak congestion periods.

Give others the benefit of the doubt; be polite and forgiving

Put your pride in the back seat. Don't challenge an aggressive driver by speeding up or attempting to hold your position in your travel lane.

Smile and chill

Ignore baiting gestures and name-calling, and do not return them. Show the person that you're not going to give them the response they want. Smiling shows the person that you're not getting angry like they want you to.

Stay focused

Keep 100% of your attention on driving at all times. That means no multi-tasking. Don't use your phone or any other electronic device while driving.
